**Ms. Martina Donlon** currently works as Information Officer for Human Rights in the Department of Public Information at UN Headquarters in New York, where she also manages the Outreach Programme on the Rwanda genocide, coordinates Nelson Mandela International Day, and serves as focal point for indigenous peoples and the International Decade for People of African Descent.
