CONCEPT NOTE

Background

The LLDC3 Civil Society Forum (4–5 August 2025), taking place alongside the Third UN Conference on Landlocked Developing Countries (LLDCs) in Awaza, Turkmenistan (5–8 August 2025), is a unique opportunity for civil society from around the world to engage directly with world leaders, UN officials, and key stakeholders to share experiences, propose solutions, and shape the sustainable development agenda toward achieving the Awaza Programme of Action for LLDCs.

Even before the COVID-19 pandemic, LLDCs faced mixed progress toward sustainable development. The pandemic amplified their structural vulnerabilities, reversing gains under the Vienna Programme of Action and Agenda 2030. LLDCs remain highly exposed to external shocks, with macroeconomic instability compounding their challenges.

Civil society is pivotal in driving sustainable development, offering innovative solutions and grassroots insights critical for LLDCs' resilience and prosperity. A multi-stakeholder approach — as requested by Member States — is essential to conduct a comprehensive review and galvanize broad support for a new generation of action. Civil society also plays a key role in bringing LLDC priorities into global policy discussions on finance, trade, climate, and beyond.

From local organizations to international networks, civil society actors are central to the development and implementation of national strategies, ensuring policies are rooted in the realities of people's lives. The success of the Awaza Programme of Action for LLDCs will rely on their active participation, alongside governments and the private sector.

- **Provide a platform** for civil society, academia, the private sector, and government to identify critical priorities, forge partnerships, and chart a way forward.
- Showcase successful partnerships and strategies that drive sustainable development in LLDCs.
- Facilitate the exchange of innovative solutions, best practices, and lessons learned in addressing LLDC-specific challenges.
