No registrations will be accepted via email and there will be **NO on-site registration for stakeholders**. ## **Youth and Innovation Forum**

The Youth and Innovation Forum, to be held from Friday, **24 June** to Sunday, **26 June**, in **Cascais**, will be a platform for advancing ocean action and implementing youth-led solutions based on SDG **14** targets. It will seek to help young entrepreneurs and innovators scale up their initiatives, projects and ideas through professional training and matchmaking with mentors, investors, the private sector and government officials. ## **Localizing Action for the Ocean: Local and Regional Governments**

Localizing Action for the Ocean: Local and Regional Governments Special Event, to be held on Saturday, **25 June**, in the City of **Matosinhos**, will create an opportunity for local and regional governments and their networks, national governments and other stakeholders to exchange good practices of SDG 14 implementation at the local level. ## **Sustainable Blue Economy Investment Forum**

The Sustainable Blue Economy Investment Forum (SBEIF), to be held on Tuesday, **28 June**, in **Cascais**, will launch a process for designing sustainable blue economies sustainable framework global standard, to be used in financial instruments, investment decisions and business. In addition, the SBEIF will be an opportunity to establish a common language for a sustainable ocean economy and to explore how to build synergies between integrated Ocean Management Plans, trade finance, marketing and distribution value chains and the private sector.

## High-Level Symposium on Water – Bridging SDG 6 and SDG 14

The High-Level Symposium on Water, to be held on Monday, **27 June**, in **Lisbon**, is one of the preparatory meetings for the UN Water Conference 2023. Trying to bridge and explore the interlinkages between Sustainable Development Goals 6 (Clean Water and Sanitation) and 14 (Life below Water), this Symposium represents a unique opportunity to bring together political leaders and high-level decision-makers dealing both with "fresh" and "salt" water, reflecting on how to better connect these two communities to guarantee an integrated vision of the water cycle. By doing so, this event provides an opportunity to strengthen the role of water and ocean in the implementation of the 2030 Agenda for Sustainable Development and the Paris Agreement and offers a platform for presenting successful best practices and partnerships. ## 2022 ECOSOC Youth Forum – SDG 14 Thematic Breakout Session

On Tuesday, 19 April 2022, the Division for Sustainable Development Goals (DSDG) of the UN Department of Economic and Social Affairs (DESA), the Oceans Youth Constituency of the Major Group of Children and Youth, UN Environment Programme (UNEP) and UN Global Compact jointly organized a special Thematic Breakout Session on Youth Action for Sustainable Development Goal (SDG) 14, as part of the annual Economic and Social Council (ECOSOC) Youth Forum. The session served as a platform for youth to showcase ideas, recommendations, innovations, youth-led solutions and actions to "Save our ocean, Protect our future". It also helped to raise awareness among youth of the 2022 UN Ocean Conference, the upcoming review of SDG 14 at the 2022 UN High-level Political Forum on Sustainable Development (HLPF) in July, the implementation of the Decade of Ocean Science for Sustainable Development as well as other related processes.
