- Digital and media literacy should be a mandate for every government, and efforts should be made to reach out to the most marginalized sections of the society who lack access opportunities. Digital technologies would provide opportunities for a greater plurality of voices to be heard and influence the public debate
- Technological surveillance should be done away with , and governments and policy makers should come together to make technology more gender-friendly and inclusive.

- We would like to recommend that free and compulsory education should be made available for children aged 6-18 years, especially for girls given that dropout rates are increasing post COVID years. - Youth should be recognised as a diverse category and recognise intersectional identities. various kinds of marginality in terms of class, caste, sexuality, ability, religion, location, etc.
- There is an urgent need to disaggregate the data about marginalized youth. Without specific budgets allocated for disaggregated sections of marginalized communities, policies will remain stagnant as advisory documents instead of implementable policies.
- Promote the leadership and visibility of youth and support youth-based organizations /youth-led organizations with sustained funding mechanisms.
- Adolescents and youth should be at the center of developmental processes at the national, regional and global levels. Decision makers should put systems and structures so that power sharing and accountability becomes a reality and engagement of young people is done by design and a mandate.
- Efforts should be streamlined for building and strengthening intersectional, youth affirmative, feminist leadership in gender equality spaces as well as participation in multilateral spaces. We need to strengthen and power feminist movements that are marginalized.
