We urge Policy Makers and Decision Makers on UN System; Governments of North and South Countries and Universities in North and South Countries to genuinely appreciate need to: shift focus away from problems and blame and shift focus towards solutions and opportunities; recognize that our World is in DEEP Crises and accelerating on MADning (Mutually Assured Destruction) Road to DOOM, that failure to change course and start accelerating on MAPing (Mutually Assured Prosperity) Road to BOOM guarantee ultimate global catastrophic consequences and that as no one knows when our World will race past irreversibility point in ongoing acceleration on MADning Road to DOOM, one day delay changing course to start accelerating on MAPing Road to BOOM may be one day too late to save our fragile planet from perishing.
