## Submission to the consultation on the Summit of the Future

Your excellencies Ambassador Leendertse and Ambassador Gertze,

In May, the <u>2023 progress report on the Global Action Plan for Healthy Lives and Well-being for All</u> (SDG3 GAP) was published by 13 global agencies that play significant roles in health, development and humanitarian responses, including the World Health Organization.

This year's progress report highlights that "even before COVID-19, the world was off track on major health-related indicators. Now, it is even further behind, and many countries face a range of overlapping health crises stemming from the impact of the pandemic, war, food insecurity and climate change".

The World Health Professions Alliance, representing 41 million health professionals in over 130 countries worldwide across dentistry, medicine, nursing, pharmacy and physiotherapy, is deeply concerned that health, and in particular progress on SDG3, is not highlighted or explicitly mentioned in the priority topics of the Summit of the Future, to take place during the United Nations General Assembly in New York City, in September 2024.

Equal access to health, including appropriate health workforce capacity of adequately trained healthcare professionals, is essential not only to ensure the achievement of SDG3, but in fact, for the achievement of all SDGs, as the basis for all human endeavours and societal development.

The Summit of the Future's <u>website</u> states that this event is a "once-in-a-generation opportunity to enhance cooperation on critical challenges and address gaps in global governance, reaffirm existing commitments including to the Sustainable Development Goals (SDGs) and the United Nations Charter, and move towards a reinvigorated multilateral system that is better positioned to positively impact people's lives." This aspiration is simply unachievable if health is not part of the discussion nor elevated high enough on the agenda.
