## Preparatory Process for the Summit of the Future Second Reading of the Zero Draft of the Pact for the Future

Excellency,

Dear Colleagues,

We want to express our sincere gratitude for the active participation of delegations in the ongoing readings of the zero draft of the Pact for the Future and for their written inputs, which have been reflected in a 242-page compilation text, circulated on 19 February 2024. We are also grateful for the inputs of major groups and other stakeholders and civil society, who have provided their valuable feedback on the zero draft, both in writing and during the informal consultations on 21 February.

Following the conclusion of the first reading of the zero draft with delegations on 8 February, we have started with a second reading on 21 February. As of 4 March, we have completed a full second reading of Chapter 2 ("International Peace and Security") and will resume with a reading of Chapter 1 ("Sustainable Development and Financing"). The reading will proceed to Chapter 3 ("Science, Technology and Innovation and Digital Cooperation") once the reading of Chapter 1 has been completed.

Please see below an updated roadmap for the remainder of the second reading. We have sought to avoid duplication with other Summit of the Future processes, as foreseen in decision 77/568. Some other major intergovernmental meetings in New York have also been taken into account to the extent possible.

We will continue with the clustering of paragraphs in order to streamline language, wherever possible. We hope this approach enhances coherence and feasibility to ensure an efficient deliberation process.

We will continue to update delegations on a rolling basis. These updates will allow us to retain flexibility to adapt the roadmap, as required.

Once again, we express our sincere gratitude to all delegations for entrusting us with their confidence and support, and their collaborative spirit as we work together towards achieving an ambitious outcome for the Summit of the Future.
