Meeting Summary

UN-Energy member and partner organizations met virtually at the technical level on 1 November 2022, 08:30 to 09:30 EST. The agenda and the list of participants are attached as Annex 1 and Annex 2.

1. Activities of UN-Energy organizations at COP27

- The Secretariat thanked the members for the written input received on the energy-related events they will be organizing at COP27. An overview list was circulated ahead of the meeting. An updated version with additional inputs will be circulated after the meeting. The list will be disseminated also to a broader audience via SDG 7 Action newsletter by the end of this week (4 November).
- The Secretariat shared information about the UN system wide official COP27 side-event “Accelerating SDG7 action: Implementing the UN-Energy Plan of Action Towards 2025 in support of the Global Roadmap for Accelerated SDG7 Action and Net-Zero Emissions” at Khufu Hall on 12 November, 13:15 - 14:45.
- UN-Energy members shared information about the events they will be organizing and other relevant activities at the COP 27.
- The Secretariat invited all to join for an informal gathering of UN-Energy colleagues at the SDG Pavilion on 15 November from 12:15 to 13:30.

2. Context for UN-Energy Work Plan 2023

- The Secretariat presented on the context for the drafting and implementation of the UN-Energy 2023 Workplan. We will soon reach the Mid-Point of the 2030 Agenda for Sustainable Development which highlights the need to action. The Global Roadmap for Accelerated SDG 7 Action provides guidance in this regard. By implementing its Plan of Action Towards 2025, UN-Energy can contribute significantly to addressing these challenges. The seven deliverables of the Action Plan must be addressed by the Work Plan 2023.
- Next steps:
 1. By the end of November, the Secretariat will reach out bilaterally to UN-Energy members to discuss their thoughts on UN-Energy priorities for 2023 and put together a draft work plan.
 2. On 6 December from 08:30 to 10:00, there will be a virtual UN-Energy meeting which will focus on discussing the activities in 2023, including the draft work plan.
