- Engaged over 1040 participants from more than 60 Member States from across 6 regions and sub-regions




UNCCT Projects by the 4 Pillars of the UN Global Counter-Terrorism Strategy and by Geographical Scope Q3/2019

Selected Activities: Pillar I Q3/2019

• PVE Plans of Action

- Initiated support to Sudan to develop a PVE Plan of Action by mid-2020
- Deployed a PVE coordinator in Bangladesh to cohere donor community and UN agencies' work on PVE
- PVE and Strategic Communications
 - 5 capacity-building workshops throughout Southeast Asia
- Violent Extremist Prisoners
 - Capacity-building assistance to Kazakhstan and Uganda
- Technical and Vocational Training and Education
 - 225 participants trained in partnership with Indonesia and Maldives
