Excellencies, Distinguished delegates, Ladies and Gentlemen,

In my capacity as Under-Secretary-General for Legal Affairs, United Nations Legal Counsel and UN-Oceans Focal Point, I am pleased to welcome you to this World Oceans Day celebration and panel discussion entitled, “Clean our Ocean: Youth and Innovation.”

In line with the theme of this year’s World Oceans Day, the panel today will focus on youth and innovation, which both play fundamental roles in cleaning our oceans and in ensuring their future sustainability and well-being.
