Delegations of Member States to the United Nations with a valid UN grounds pass can access the 2025 SDG Moment taking place at the ECOSOC Chamber, on  $22^{nd}$  September, from 2:00 to 4:00 PM directly from the  $3^{rd}$  floor of the Conference Building. Those with a floater (gold/blue) may access the ECOSOC Chamber from the  $2^{nd}$  floor.

There will be no meeting-specific tickets issued to Member States for this event. Please DO NOT contact or follow up with the Protocol Office for tickets.

Delegations of accredited intergovernmental organizations accredited by the General Assembly, specialized agencies and related organizations with a valid UN grounds pass can access the 2025 SDG Moment taking place at the ECOSOC Chamber, on 22<sup>nd</sup> September, from 2:00 to 4:00PM directly from the 3<sup>rd</sup> floor of the Conference Building. Those with a floater (gold/blue) may access the ECOSOC Chamber from the 2<sup>nd</sup> floor.

Registration (request of UN grounds pass) is handled by the Protocol Office via the eRegistration system at <a href="http://e-delegate.un.org">http://e-delegate.un.org</a>.

There will be no meeting-specific tickets issued to accredited intergovernmental organizations accredited by the General Assembly, specialized agencies and related organizations for this event. Please DO NOT contact or follow up with the Protocol Office for tickets.

## iii. Entities within the UN system<sup>1</sup>

Staff of the United Nations system will need a meeting-specific ticket to attend the SDG Moment, taking place on 22<sup>nd</sup> September, from 2:00 to 4:00 PM at the ECOSOC Chamber.

They can access directly from the 3<sup>rd</sup> floor via the gallery of the ECOSOC Chamber. Their UN badge, along with the meeting specific ticket, should enable them to gain access to UN premises in New York. **Registration:** Civil society wishing to attend in their individual capacity the 2025 SDG Moment taking place at the ECOSOC Chamber, on 22<sup>nd</sup> September, 2:00 to 4:00 PM, can submit their request for a meeting specific ticket via email to <u>decadeofaction@un.org</u> by <u>Monday, 15 September, 11:00 AM.</u>

Their request will need to indicate the first and last names of the people attending, as they appear on their respective IDs, their organization, and their title, for security clearance first. The physical tickets will then be distributed in person closer to the date of the event, depending on the availability of the seating and on security clearance. Further information to confirmed participants will be shared on the distribution of the physical tickets at a later stage, via email.

#### Access to the venue:

With their name specific tickets and their valid government issued photo ID, civil society can enter the United Nations compound and then access the ECOSOC Chamber from the 3<sup>rd</sup> floor, to attend the SDG Moment.

Due to security restrictions for the High-Level week of the General Assembly, access to the United Nations Headquarters will be via the checkpoint at the <u>46th Street and 2nd Avenue</u> and will be screened at the <u>47th Street and 1st Avenue entrance</u>. Participants should arrive at least one hour prior to the start of the event to ensure enough time for the mandatory security screening and to be seated.

#### v. Media

# vi. Security

Within the United Nations premises, all persons are required to comply with safety and security regulations, as well as the rules and procedures of the organization. Any act that disrupts the normal functioning of the Organization's programmatic activities, such as public displays of any form, including, but not limited to, clothing, banners, placards or other written or visual means, as well as vocal/audio sounds, gatherings, or demonstrations of any kind, including passive, is not allowed. All individuals present on the United Nations premises are expected to fully cooperate with United Nations security officers at all times. Refusal to comply with applicable regulations may result in temporary detention, removal from or denial of access to the premises in accordance with Section 10 of the United Nations Headquarters Agreement and ST/Al/2019/5, entitled "Authority of United Nations Security Officers".
