# Building a gender resource library in Jordan Field Office (JFO)

Last month the Jordan Field Office (JFO) Gender Mainstreaming team established a "Gender Resource Library", and uploaded more than 30 resources, as the foundation for this reference source. The library will provide a platform for all UNRWA staff to access gender mainstreaming tools, training materials, and academic texts and documents, enabling increased awareness of the effectiveness of gender mainstreaming in UNRWA operations.

The library is an evolving project, and will be updated regularly with relevant information as it becomes available. As such, the Gender Mainstreaming team actively seeks feedback and contributions from all UNRWA staff with relevant material or programme activity 'best-practices', images, academic texts or teaching resources

# Building community self-protection capacity to prevent GBV in JFO:

As part of the USG funded project "Building Safety", JFO is piloting a new methodology aimed to enhance self-protection capacities within the community. The methodology, called "Building Self-Protection", consists of a participatory protection assessment with UNRWA students, parents and teachers that will enable the community to take measures and address protection concerns with a focus on GBV. The methodology has three stages:

- 1. Community risks assessment to increase understanding of unsafe places, threats and barriers to access.
- 2. Community Resource mapping (assets mapping) to locate and explore possible resources available in the communities.
- 3. Protection Roadmap, linking risks with assets to put in place feasible solutions through community mobilization.

united nations relief and works agency for palestine refugees in the near east The methodology, designed by JFO Neutrality and Protection Unit in close coordination with education programme, is currently being implemented in 24 UNRWA schools in Jordan with the active participation of School Counselors who commendably volunteer as GBV Focal Points within the JFO GBV Network. After the implementation of the three first exercises of the methodology, a learning workshop was held on the 15th of August to assess the design of the methodology and its activities, to identify lessons learnt and to prepare the implementation of the next stages of the methodology.

## inspiring story

Doctor Hayat, the first female biotechnology doctor in the Arabian gulf

Dr. Hayat Sindi, a Saudi Arabian medical scientist has been accepted into Cambridge University to pursue a PhD in biotechnology, making her the first Arab woman to pursue a PhD in this subject. Dr. Sindi is also one of the first women in the Consultative Assembly of Saudi Arabia, and has continued to make major contributions in the field of medical testing and biotechnology. She was recently ranked by Arabian Business as the 19th most influential Arab in the world. In 2010, Sindi was the winner of the Mecca Al Mukaramah prize for scientific innovation, given by His Royal Highness Prince Khalid bin Faisal Al Saud. She was also named a 2011 Emerging Explorer by the National Geographic Society. On October 1, 2012, Sindi was appointed to be a Goodwill Ambassador, by the head of UNESCO for her efforts in promoting science education in the Middle East, especially for girls. She was also on Newsweek's 2013 list of 150 women who shook the world for that year. Read more

The United States Celebrates the Anniversary of Women's Right to Vote, August 26

The national celebration has been held annually since 1973. It commemorates the 1920 adoption of the 19th Amendment, which granted women the constitutional right to vote.

Many Twitter users applauded the efforts of female suffragettes, while noting that more progress needs to be made to ensure equality for all women, including women of color and women with disabilities, since even after the 1920 amendment, Jim Crow laws in the South prevented many African-Americans male and female from voting until the passage of the Voting Rights Act in 1965. # Regional News

Tunisia: Tunisian president Beji Caid Essesbi, as well as upcoming legislation that would vows to give women equal inheritance rights. He says he will submit a bill to the parliament granting women and men equal inheritance rights, in line with a proposal put forward by a government-backed committee. A report by the Individual Freedoms and Equality Committee released in June sought to address a number of issues related to individual freedoms and gender equality, but drew the ire of the country's conservative forces. Read more

Egypt: Women's rights activists and jurists hailed a decision by the Supreme Judiciary Council earlier this month to promote 16 female judges. Female activists in Egypt have been pushing for efficient implementation of new laws that protect women, such as the penalization of female genital mutilation and jail terms for those who marry underage girls

penalize families who allow such marriages. They ask for maximum penalties for domestic violence, swift divorce under fair conditions for women and a zero-tolerance attitude toward harassment and rape. Read more

Gaza: In May 2018, the Women's Health Centre launched a campaign to address the slow proceedings of courts in the event of divorce, as some divorce proceedings span over 10 years. The campaign is part of a program to combat increasing GBV against girls and displaced women in Gaza, and is implemented in partnership with the United Nations Population Fund (UNPFA). The organization has promoted the campaign over social media and enlisted the help of legal associations to help bring decision makers to actions. Read more

The authors speculate that women have an impact in reducing corruption because they choose policies that are related to the welfare of women, children, and families.
