In 2019, UNRWA finalized the Building Safety Project on gender-based violence (GBV), conducted the end line study for its GBV prevention work, and drafted a transition plan to further mainstream GBV in its programmes. In terms of advocacy, UNRWA marked International Women's Day, participated in the review of Beijing +25, and organized a myriad of activities for the 16 days of activism campaign. In 2020, UNRWA looks forward to reinforcing the implementation of its Gender Equality Strategy (2016-21).

16 Days of Activism Against GBV

ed a hand-printing mural to raise awareness about GBV. The West Bank Field Office coordinated a youth initiative activity that conveyed messages about GBV prevention through a play created and acted by youth. In Lebanon, the school counsellors implemented various activities including marches from "safe havens" in the community, art sessions, and open forum discussions on GBV. At the closing ceremony at Yarmouk School, UNRWA students performed theater plays and exhibited artwork related to ending GBV UNRWA organized ceremonies to celebrate the campaign. The Syria Field Office facilitated workshop on women's rights and family laws for 81 women and 9 men and rolled out puppet show to 1,500 children to raise awareness about violence and harassment.

A group of thirty men in Gaza have succeeded in preventing the early marriage of girls under the age of 18, from 50 different families, thanks to a training programme supported the UN Women. One of them, Mossa Abu Taema, a doctor by profession, said that child marriage cannot be consensual. "As a medical doctor, I couldn't bear the negative effects that early marriage brings to a young girl's health." He convinced the father of a 16-yearold in one of the most conservative villages in eastern Khan Younis, a border town in the Gaza Strip, to cancel her wedding and allow her to continue her education. regional news

Saudi Arabia ends gender segregation in restaurants. It used to be mandatory for all restaurants to have one entrance for families and women, and another for men on their own in Saudi Arabia. The restrictions had already been quietly eased in practice, with many restaurants, cafes and other meeting places no longer enforcing segregation. In Dec 2019, the Saudi ministry of municipalities announced that restaurants would no longer need to maintain sex-segregated entrances. Instead it would be left up to businesses to decide. Sudan Sovereign Council and cabinet approved a bill ending the notorious public order and public morals law, which used to regulate women's clothing and public morals by punishing violators with flogging. Launching the 16 days campaign, Minister of Labor and Social Development Lena El-Sheikh, pledged to combat all forms of violence against women, to review or abolish existing laws and legislation restricting women's freedom, to guarantee women's basic legal and political rights and to provide them with security. Gender Justice and Equality before the law in Arab State This report marks the culmination of an ambitious four-year project that engaged governments, civil society organizations and UN agencies in 19 Arab states, as well as regional agencies. The report focuses on the laws and law enforcement practices that matter most for women and girls: protection from violence, rights within the family, property rights and rights at work. The report points to examples of good practice from across the region and encourages sharing of experiences and crossfertilization of ideas. More here.

Gender Equality and Violent Extremism UN Women, Monash University and its partners have conducted extensive research across the Libya, Maghreb, and Tunisia over the past two years. The reports explore how social constructions of masculinity and femininity, and gender dynamics are manipulated by violent extremist groups through their recruitment strategies. It also examines the strategies women in North Africa have employed to prevent the spread of violent extremism. It is found that protecting women's rights in North Africa is key to ending violent extremism. More here.
