

List of publicly available resources: Gaza Strip and UNRWA's financial situation May 2021

The United Nations Relief and Works Agency for Palestine Refugees in the Near East ("UNRWA" or "the Agency") often receives questions about our operations in Gaza and other fields from individuals, their legal representatives and authorities outside UNRWA areas of operation.

UNRWA provides humanitarian assistance and mandated services, primarily in the form of education, health and mental health care, relief and social services, microcredit and emergency assistance to some 5.7 million registered Palestine refugees located within its five fields of operation (Jordan, Lebanon, Syria, West Bank, including East Jerusalem, and Gaza) pending a just and lasting solution to their plight. UNRWA has no mandate to operate outside its fields of operation or to seek durable solutions for refugees.

UNRWA regularly issues publicly available information relating to its services and, where available, the humanitarian and protection situation in UNRWA fields. The resources listed here contain recent information in relation to the humanitarian situation in the Gaza Strip and UNRWA's operations, including financial situation. Background Information

UNRWA is confronted with an increased demand for services resulting from a growth in the number of registered Palestine refugees, the extent of their vulnerability and their deepening poverty. UNRWA is funded almost entirely by voluntary contributions and financial support has been outpaced by the growth in needs. As a result, the UNRWA programme budget, which supports the delivery of core essential services, operates with a large shortfall. UNRWA encourages all Member States to work collectively to exert all possible efforts to fully fund the Agency's programme budget. UNRWA emergency programmes and key projects, also operating with large shortfalls, are funded through separate funding portals.
