1. Bureau Meeting with UNRWA Chief of Staff



On 18 July, the Bureau of the Committee, headed by Ambassador Cheikh Niang, met with Mr. Ben Majekodunmi, Chief of Staff of UNRWA, and Ms. Gréta Gunnarsdóttir, Director of [UNRWA's Office](#) in New York. During the meeting, the Bureau received a briefing on the recent [Advisory Commission](#) meeting in Beirut, discussed the Agency's financial situation and suggested collaborative initiatives for [UNRWA's 75th anniversary](#), reaffirming their support for the Agency's work.

2. Committee Virtual conference on the question of Jerusalem



On 20 July, the Committee, in cooperation with the Organisation of Islamic Cooperation (OIC), convened a virtual Conference on “The impact of Israeli settlement policies on the Palestinian population in Jerusalem”. The conference was officially opened by ASG Khaled Khiari and a representative of the OIC. Later, four civil society representatives from Palestine, Israel and the United States highlighted Israel’s ongoing illegal practices restricting freedoms of Palestinians in Jerusalem and emphasized the importance of economic activism in countering Israel’s occupation. Speakers further underlined how the UN database of business enterprises linked to settlements in the Occupied Palestinian Territory (OPT) can be an important advocacy tool.

3. The Committee Vice-Chair addresses the quarterly Security Council Open Debate on the situation in the Middle East, including the Palestinian question



On 27 July, the Permanent Representative of Malaysia and Vice-Chair of the Committee, H.E. Ahmad Faisal Muhamad, delivered the Committee's statement at the Security Council Open Debate on the situation in the Middle East including the Palestine Question. The Committee condemned the continued attacks on Palestinian civilians, including women and children, and the raids on Palestinian villages. It further welcomed the UN High Commissioner for Human Rights' call for Israel to align its policies and actions in the Occupied Palestinian Territory, including East Jerusalem, with international human rights standards and humanitarian law.

4. Bureau holds internal planning meeting



On 21 August, the Bureau held a strategic meeting to plan upcoming activities for the fourth quarter of 2023. The Observer Mission of the State of Palestine briefed on political developments on the ground and the ongoing ICJ Advisory Opinion. The Bureau discussed the adoption of the 2023 Annual Report, initiated plans for the annual Bureau Retreat, considered CSO accreditation requests and formally endorsed the Legal [Study](#) commissioned by the Committee to examine the legality of the Israeli occupation of the OPT, including East Jerusalem (see entry 7).

5. Bureau meeting with the UN Secretary-General



On 22 August, the Bureau of the Committee met with UN Secretary-General António Guterres to express concern at the worsening situation in the Occupied Palestinian Territory (OPT), including East Jerusalem. Ambassador Cheikh Niang, the Chair of the Committee, urged the Secretary-General to visit the OPT and stressed the importance of enhancing the protection of the Palestinian population. The Secretary-General reiterated the UN support for the two-State solution and expressed his wish to visit the OPT soon.

6. The Committee adopts its Annual Report 2023 and launched a Legal Study



On 30 August, the CEIRPP adopted without amendments its 2023 Annual Report that will be presented at the 78th General Assembly session in November. The State of Palestine provided updates on the political and humanitarian situation in the OPT and requested Member States'

support for full UN membership. In addition, Professor Michael Lynk briefed on the findings of the [study](#) commissioned by the Committee on the Legality of the Israeli Occupation and marking its official launching. The Committee accredited one CSO based on the Bureau's recommendation.

7. Official Launch: Study of the Legality of the Israeli occupation



On 30 August, the Committee launched a study on the Legality of the Israeli Occupation of the Occupied Palestinian Territory, including East Jerusalem. The independent and impartial research study conducted by a highly respected academic institution examined the legality of Israel's occupation through the lenses of international law and legal precedents.
