Bio Note

Francesca Albanese is the UN Special Rapporteur on the Situation of Human Rights in the Palestinian Territory Occupied Since 1967. She is an Affiliate Scholar at the Institute for the Study of International Migration at Georgetown University, and a Senior Advisor on Migration and Forced Displacement for the think tank Arab Renaissance for Democracy and Development, where she co-founded the Global Network on the Question of Palestine, a coalition of renowned professional and scholars engaged in/on Israel/Palestine. She has published widely on the legal situation in Israel/Palestine.

Tlaleng Mofokeng is the UN Special Rapporteur on the Right to Health. She is a medical doctor with expertise advocating for universal health access, HIV care, youth friendly services and family planning. Tlaleng Mofokeng is a member of the boards of Safe Abortion Action Fund, Global Advisory Board for Sexual Health and Wellbeing, Accountability International. Ms. Mofokeng has been Commissioner at the Commission for Gender Equality in South Africa and advisor to the Technical Committee for the National Adolescent Sexual and Reproductive Health and Rights Framework Strategy in South Africa, successfully mobilizing across movements working on issues of children and adolescents, persons with disabilities, migrants and persons living with HIV/AIDS.

Chris Sidoti is a Commissioner of the Independent International Commission of Inquiry on the Occupied Palestinian Territory, including East Jerusalem, and Israel. He is the founder and an International Expert of the Special Advisory Council for Myanmar and was one of the Members of the UN Independent International Fact-Finding Mission on Myanmar from 2017- 2019. He has also provided consultancy services on human rights law to the OHCHR, UNDP, UNICEF, and the Asia-Pacific Forum of National Human Rights Institutions, among others.

Diana Buttu is a Member of the Board of Commissioners of the Independent Commission for Human Rights of Palestine, and a Palestinian lawyer from Ramallah. She previously worked as a legal advisor to the Palestine Liberation Organization and was a member of the team that worked on raising the legality of the Separation wall before the International Court of Justice. Ms. Buttu is a commentator on the Palestinian issue in the international media, and a political analyst for Al Jazeera International.

Anisha Patel is Governing Council Member and Head of Content and Discourse Department at Law for Palestine. She is currently a doctoral researcher in Germany. She has background in international law, heritage studies, and architecture. She has worked with governmental and inter-governmental organizations related to the UNESCO World Heritage system as well as the intersection of heritage and peace with a focus on community-based processes.
