# INTERNATIONAL CONFERENCE ON FINANCING FOR DEVELOPMENT

1st plenary meeting

Opening of the Conference [1]

The Under-Secretary-General of the Department of Economic and Social Affairs, on behalf of the Secretary-General, opened the Conference.

Election of the President of the Conference and Co-Presidency of the high level officials and ministerial segments [2]

President of the Conference

H.E. Mr. Vincente Fox, President of Mexico, was elected, by acclamation, President of the Conference.

Co-Presidency of the ministerial segment

His Excellencies Mr. Jorge G. Castañeda Gutman, Minister of Foreign Affairs of Mexico, Mr. Francisco Gil Díaz, Minister of Finance of Mexico, and Mr. Luis Ernesto Derbez Bautista, Minister of Trade of Mexico, were elected, by acclamation, as Co-Presidents of the ministerial segment.

Co-Presidency of the high-level officials segment

His Excellencies Mr. Miguel Hakim Simón, Vice Minister of Foreign Affairs of Mexico, Mr. Agustin Carstens Carstens, Vice-Minister of Finance of Mexico, and Mr.Luis Fernando de la Calle, Vice-Minister of Trade of Mexico, were elected, by acclamation, Co-Presidents of the high-level officials segment. The Co-Presidents were then invited to take their seats at the podium to conduct the plenary meeting of the high-level officials segment.

Adoption of the rules of procedure [3]

The Conference began consideration of agenda item 3.

The rules of procedure, as contained in document A/CONF.198/2, were adopted by the Conference.

The Conference concluded its consideration of agenda item 3.

Adoption of the agenda and other organizational matters [4]

The Conference began consideration of agenda item 4.

The agenda, as contained in document A/CONF.198/1/ Rev.1, was adopted by the Conference.

Accreditation of intergovernmental organizations

The Conference approved the accreditation of the following five intergovernmental organizations as recommended by the Bureau of the Preparatory Committee: Commonwealth Foundation, Banque des Etats de l'Afrique Centrale, Partners in Population and Development: a South-South Initiative, International Association of Economic and Social Councils and Similar Institutions and Eastern Caribbean Central Bank.

Accreditation of non-governmental organizations

The Conference approved the accreditation of the following two non-governmental organization as recommended by the Bureau of the Preparatory Committee: Institute for International Economics and Center for Global Development.

Election of officers other than the President [5]

The Conference began consideration of agenda item 5.

The Co-President inform the Conference of the recommendations concerning the composition of the General Committee and the distribution of posts therein.

The following five States from the African Group of States were elected, by acclamation, Vice-Presidents of the Conference: Cameroon, Egypt, Ghana, Namibia and Sudan.

The following five States from the Asian Group of States, were elected, by acclamation, as Vice-Presidents of the Conference: Bangladesh, Islamic Republic of Iran, Japan, Pakistan and Thailand.

The following five States from the Eastern European Group of States, were elected, by acclamation, as Vice-Presidents of the Conference: Bulgaria, Czech Republic, Poland, Romania and The Former Yugoslav Republic of Macedonia.

The following four States from the Latin American and Caribbean Group of States were elected, by acclamation, Vice-Presidents of the Conference: Chile, El Salvador, Saint Lucia and Trinidad and Tobago.

The following five States from the Western European and other States Group, were elected, by acclamation, Vice-Presidents of the Conference: Denmark, France, Sweden, Turkey and the United States of America.

Election of the Vice-President ex officio of the Conference

His Excellency Dr. Jorge Castañeda Gutman, Minister of Foreign Affairs of Mexico, was elected, by acclamation, Vice-President *ex officio* of the Conference.

Election of the Rapporteur-General

The Co-President informed the Conference that more consultations were needed to elect one of the Vice-Presidents of the Conference to serve also as Rapporteur General of the Conference.

Organization of work, including the establishment of the [Main Committee], the high-level officials segment, the ministerial segment and the Summit segment [6]

The Conference began consideration of item 6 of the agenda.

The Conference approved the organization of work as contained in document A/CONF.198/4/Rev.1.

The Conference endorsed the proposals contained in document A/CONF.198/4/Rev.1 regarding the exchange of views and the composition of the Bureau of the General Committee, the high-level officials segment, the ministerial segment and the summit segment.

The Conference approved the proposed time-table of work for the Conference and the organization of meetings, as contained in document A/CONF.198/4/Rev.1, as orally revised.

The meetings for the high-level officials segment and the ministerial segment would be scheduled from 10 a.m. to 1 p.m. and from 3 p.m. to 6 p.m. The meetings of the summit segment, would be scheduled from 9 a.m. to 1 p.m. and from 3 p.m. to 9 p.m.

*Credentials of representatives to the Conference* [7]

(a) Appointment of members of the Credentials Committee

The Conference began consideration of agenda item 7.

It was decided that the composition of the Credentials Committee would be based on that of the Credentials Committee of the General Assembly of the United Nations at its fifty-sixth session as follows: China, Denmark, Jamaica, Lesotho, the Russian Federation, Senegal, Singapore, the United States of America and Uruguay. With regard to the report of the Credentials Committee, it was the understanding that if one of those States did not participate in the Conference, it would be replaced by another State from the same regional group.

#### High-level officials segment

High-level officials segment (A/CONF.198/5) [8]

(c) Reports on activities by relevant stakeholders:

The Conference began consideration of agenda item 8 (c).

The Co-Chairs of the Preparatory Committee of the International Conference on Financing for Development, the representatives of Pakistan and Sweden, made statements.

(a) General exchange of views

The Conference began consideration of agenda item 8 (a).

Statements were made by the following Executive Secretaries of the regional commissions: Economic Commission for Europe (ECE), Economic and Social Commission for Asia and the Pacific (ESCAP), Economic Commission for Latin America and the Caribbean (ECLAC), Economic Commission for Africa (ECA) and the Economic and Social Commission for Western Asia (ESCWA).

The Co-President informed the Conference that some of the speakers listed under sub-items 8 (a) and (c) would speak in the afternoon meeting.

Consideration of the "Draft Monterrey Consensus" [8 (b)]

The High-level officials segment adopted the "Draft Monterrey Consensus" and transmitted it to the Ministerial Segment.
