#### **INTRODUCTION**

The 60th Session of the United Nations Commision on the Status of Women (60th CSW) provides an opportunity through its priority theme "Women's empowerment and its link to sustainable developemnt" to focus on The Sustainable Development Goals (SDG) especially Goal #5 which is dedicated to gender equality by a specific target: "Achieve gender equality and empower all women and girls [1]. UN Women Liberia and partners have agreed to organize a side event during the 60th CSW. The side event will address the influence of culture as a catalytic effect on women and girls empowerment. The panel will highlight the impact of beliefs, tradition and practices that have prevented economic empowerment of women and girls and the experts will discuss how these challanges can be turned into possibilities and opportunities with the collaboration of civil society organizations, educational institutions, intergovernmental organizations and governments.

#### **OBJECTIVE**

While this panel addresses some of the challenges tradition poses for women's empowerment, it primarily seeks to discuss the importance of utilizing local tradition and culture in achieving women's equality and empowerment as stated in UN Sustainable Development Goal 5. It is frequently mentioned in the SDGs' adoption that"there are different approaches, visions, models and tools available to each country, in accordance with its national circumstances and priorities, to achieve sustainable development"[3].











Connecting with tradition/traditional practices and local culture can be a powerful approach, model, and tool for the what context? context, because people are invested in their traditions and culture, as it is already how they understand and organize their lives.

Roberta Clarke is the first Regional Director of UN Women for the Asia Pacific and Representative in Thailand. She also served as Senior Gender Advisor for UNDP in Burundi as part of the Bureau for Crisis Prevention and Recovery (BCPR) global program on advancing gender equality and women empowerment.

Awa has extensive experience on partnership, including with Government, Parliament, Civil Society and Women Organizations, Political Parties, bilateral and multilateral agencies and the media. She also has vast experience working with regional bodies including the African Union and the Regional Economic Communities including ECOWAS and known within the Africa region for her policy-level involvement in the 2000 democratic transition in Senegal and for her work as an activist for the promotion of women political participation and economic empowerment.
