The Council of Global Unions Working Group on Migration (CGU-WGM) joins with the International Labour Organization (ILO) to organize a side event during the third round of negotiations on the United Nations Global Compact for Safe, Orderly and Regular Migration, taking place at UN Headquarters in New York, from 3-6 April, 2018.

The session aims to:

- Stimulate a dialogue among civil society and other stakeholders, as well as Government representatives and specialized agencies, focused on the ILO's Fair Migration Agenda, linked to Decent Work as central to a core set of objectives in the current draft of the Global Compact;
- Demonstrate how the ILO works with constituents and partners at regional and national levels to advance a fair labour migration agenda aimed at improving the lives and livelihoods of migrant workers, while reducing skill gaps;
- Highlight real life examples to illustrate how the application of this rights-based, normative framework to migration policy and programme activities on the ground serves to advance the best interests of migrant workers, while responding to labour market needs;
- Demonstrate how the standard-setting and operational expertise of the ILO in the field of international labour migration can enrich the substantive

content of the global compact, as well as the implementation, follow-up and review mechanisms to be agreed.
