Participants will be divided into three working groups with the following themes:

- Violence against women, including trafficking in women
- Equality and non-discrimination: education and stereotypes
- Equality and non-discrimination: employment

Each working group will be given a set of concluding comments from one of the countries represented at the workshop and asked to identify (i) concerns and recommendations of the Committee relating to their working group theme; (ii) measures that may be taken to implement the recommendations; (iii) challenges to implementation as well as good practice examples; (iv) various stakeholders that may be involved in implementation and strengths and capabilities of each stakeholder; and (v) measures to enhance cooperation and coordination among the stakeholders.

Parallel country groups on implementation and follow-up of concluding comments: drafting a national strategy

Participants will be divided into 6 country groups (each group consisting of all the participants from a particular country) and tasked with drafting a national strategy to implement the concluding comments issued to their particular country using the analytical framework developed in the previous working group. Such strategy shall include consideration of (i) various measures to implement concluding comments (such as legislation, policies, programmes and services); (ii) the timeline for implementation; (iii) identification of resources needed to implement the measures; (iv) mechanisms for effective collaboration among the various stakeholders and for monitoring of implementation; and (v) preparation of next report.
