Project 2: ECLAC has recently signed a three years Cooperation agreement with the Regional Programme of Gender Training and Public Policies (*Programa Regional de Formación en Género y Políticas Públicas - PRIGEPP*) for the constitution of the UNESCO Regional Chair on Women, Science and Technology. The Chair was inaugurated on 4 December 2001 and pretends to constitute a regional space for the production and dissemination of new knowledge, including training, on the participation, contributions, practices and requests of women in the area of Science and Technology. The project is financed by the European Union and the Latin American Faculty for Social Sciences in Argentina (*Facultad Latinoamericana de Ciencias Sociales - FLACSO-Argentina*) and also receive the support of UNESCO and the Network of Canadian Chairs on Women, Sciences, Technology and Engineering. The work plan for the next two years is centered on the execution of a Research on Gender and Public Policies of Science and

Technology in various countries of Latin America and the Caribbean and will include the launching of a website as well as the elaboration of strategic proposals for training toward the implementation of technology-based women enterprises. The contribution of ECLAC will be essentially in kind.

BACKGROUND ON GENDER EQUALITY WEBSITE

One of the priority areas for strengthening communication about gender equality issues and gender mainstreaming, both in-house and externally, is the new ILO Gender Equality Website.

A unique feature of this database-driven site, which will be launched by the Bureau for Gender Equality in March 2002, is that it will be owned by all of the members of the ILO Gender Network. Some outside contributors will also be invited to update information on the site about relevant activities and resources of their organizations.

More details about the purpose of the site, its users and contents, and its development timeline and consultation process are briefly described below.

Purpose of the Site

The new site will serve as a gateway to information and resources on relevant issues, as well as an overall entry point for information on the ILO's actions and policy concerning gender equality. It will serve as an effective "bridge" for outside users into the organization's resources, and for ILO staff seeking both in-house knowledge and external information and resources.

Users and Contents of the Site

In addition to external users, ILO users will include management as well as professional and support staff. All will be able to access the site for quick direction to help on gender topics, basic information, and guidance materials, among other things.

The Gender Network, academics, specialist media and institutions working on gender issues will be able to exchange information through a resources database, as well as network through a links mechanism.

The site will also highlight ILO events and achievements in the area of gender equality for in-house users, constituents, UN agencies, the media and the public.

And a gender knowledge tool, which will initially be accessible only to ILO staff, will provide

access to in-house knowledge contained in documents such as technical and mission reports.

Timeline and Consultation Process

First Phase

During July and August 2001, the Gender Bureau worked with two technical consultants on the first phase of the site redesign, which concerns developing its overall logic and identifying contents. A small consultation at headquarters on 21 September was held with some members of the Gender Network for their feedback on the contents of key pages. The sample pages were also sent to all other members of the Gender Network for their comments.

Second Phase

The second phase of the site redesign, which concluded at the end of October, focused on initial functionality. At the conclusion of this phase, a second consultation will be held at headquarters on 5 November to discuss a more developed version of the prototype pages. During this phase, some technical changes to the site without extra cost are possible.

Third Phase

This phase, which focuses on refinement, begins in November. In December, an online version of most of the site will be available for viewing by Gender Network members at headquarters and in the field. During this phase technical changes to the site will not be possible without extra cost implications.

In the following two months leading up to the launch of the website in March 2002, efforts will focus on identifying and gathering content for the site. As soon as the relevant pages are available electronically, Gender Network members will receive a message from the Gender Bureau about how they can directly input information that they would like to feature on the site. One of the priorities will be to design this mechanism in order to make inputting quick, simple and easy.

Project 1: Title: Mainstreaming a Gender Perspective in Multidimensional Peace Operations: Phase II

Objective: The second phase is to be an **implementation phase** and will focus on developing tools and mechanisms to mainstream gender in all aspects of peace operations. Standard operating procedures (SOPs) for gender mainstreaming will be developed for incorporation into ongoing peacekeeping operations and new peacekeeping operations. Examples of good practices will be identified for incorporation into departmental policy. In addition, tools will be developed to monitor and evaluate progress. One of the tasks the consultants will undertake is to establish a virtual resource centre. This virtual resource centre will provide electronic access to information on gender mainstreaming and peacekeeping and will be available to staff both at headquarters and field missions.

Project 2—Title: Strategic Manual for Multi-dimensional Peacekeeping

Objective: DPKO's Best Practices Unit will, as part of its new mandate, develop generic guidelines, procedures and related tools for peacekeeping. The first such product will be a multi-dimensional peacekeeping manual. The manual will divide into two main sections. The first will be a strategic overview of multi-dimensional peacekeeping, describing the underlying rationale for such operations and the ways the elements should fit together so that the whole is more than the sum of its parts. The second part of the project will be a separate electronic volume, to be issued in CDROM format and as a Lotus Notes data base, and will be a much more detailed manual of guidelines and procedures, a "how to" section. One of the main 17 sections is on gender mainstreaming.

Financial resource allocation: Donor funded

Timeline: Draft chapters on the first five of these components were to have been completed by the end of December 2001 and the remaining components by mid-April 2002.

Project 1: UNCTAD Intergovernmental Expert Meeting on Mainstreaming Gender in Order to Promote Opportunities, held in Geneva on 14-16 November 2001, which included the agenda item "Mainstreaming gender in ICT policy". Objective: to further enhance the understanding and strengthen the consensus of member states on the developmental role of gender. ITU participated as a speaker in the meeting. The outcomes of the meeting include a set of recommendations to governments, the international community and UNCTAD on policies and activities that should be undertaken to incorporate the gender dimension into policy dialogue and decision making. The results will be considered by the UNCTAD Commission on Enterprise, Business Facilitation and Development at its 6th session on 18-21 February 2002. A set of recommendations for further work of UNCTAD in this area is expected to result from the meeting

Project 2—Analytical work on the issue of gender, ICT and development. UNCTAD is planning to include a chapter on gender and ICT in its next issue of the Electronic Commerce and Development Report 2002 (to be released in November 2002). The chapter will assess the extent to which the development of ICT and e-commerce can create new economic opportunities for women. It will use empirical data and case

studies from developing countries to illustrate the impact of ICT on employment and business opportunities for women. It will also provide a comprehensive set of policy recommendations on how to mainstream gender in national strategies for ICT and e-commerce, which will contribute towards increasing the competitiveness of the developing countries.

Project 3: Developing New Government-Civil Society Alliances for Addressing the Gender and Development Dimensions (planned project proposal)

Objectives: to develop and apply operational concepts for characterizing the gender impact of globalization and liberalization at the national level; to assemble comparative data reflecting these concepts drawn from a sample of country case studies; to assess the gender impact of globalization and to develop strategies to deal with it at the national, regional and international levels and to apply a strong participatory approach involving systematic consultations with civil society actors. The ITU team has participated in the Preliminary Conceptual Meeting, which was held in July 2001, and continue to work with UNCTAD's CSO team on the project. Specific policy findings from sectoral analysis of the gender impact in the area of information and telecommunication technologies shall/would be submitted for consideration by Governments, civil society including private sector participants at the World Summit on the Information Society (WSIS) in Geneva (2003) and Tunis (2005). This segment will be carried out in close cooperation with ITU.

Project 1: A project on "Capacity-building for Women in Africa and the Middle East to access and use ICTs" has been planned to start during 2002. This project will aim to (1) assess needs in ICTs; (2) build capacity through training including training of trainers; and (3) promote and/or strengthen existing ICT networks in 10 pilot countries in Africa and the Middle East. Partners will include ECA and ESCWA, and the Division for the Advancement of Women (DAW) will oversee the project. The total estimated budget is US \$625,000.

Project 2: In March 2003, one of the two thematic issues before the Forty-Seventh session of the Commission on Status of Women (CSW47) is "Participation and access of women to the media, and information and communication technologies and their impact on and use as an instrument for the advancement and empowerment of women." In 2002-2003, US \$70,000 from extra-budgetary resources and approximately US \$50,000 from the regular budget has been allocated to this area of women and ICTs. An expert group meeting organized by the Division for the Advancement of Women (DAW) on this theme is planned for the second half of 2002, and the report of the meeting will be widely circulated. FOSTERING E-QUALITY
BUILDING GENDER-RESPONSIVE ICT DEVELOPMENT

We have learned, over and over again, that the cost of exclusion is too high.
(Noeleen Heyzer, Executive Director, UNIFEM)

African women traders using the web to get the latest prices on their goods and women activists organizing global e-campaigns to end violence are just two examples of the real economic and political opportunities ICTs are presenting to women. The success stories, however many, still stand in stark contrast to the reality of the gender digital divide. The costs and the benefits associated with the growth and development of ICTs are not being shared equally - not between men and women, nor among countries and communities. With the exception of the United States, women in virtually all other countries use ICTs less than men.

Women are 19% of users in South Africa, 13% in the Netherlands, and 8% in China (TFGI/ITU August 2000). Disparities in use are only one piece of a much larger and more complex picture.

Globally, the capacity and knowledge to build gender E-quality in ICTs is growing. In innovative and dynamic ways, gender advocates are designing tools to "audit" ICT policy, new web sites are bringing resources and policy debates to more women in their own languages on issues that concern them locally, and gender issues have been addressed in a number of high-level national and global consultations on ICTs. Still, considerable gaps exist not only in the information available to describe the gendered nature of the opportunities and impacts of ICTs and knowledge for development, but in the understanding of the precise gender dimensions of ICTs. And, concerns for gender E-quality are not being adequately integrated into emerging ICT for development policy or practice.

UNIFEM: Building Gender E-quality in ICTs

In collaboration with its partners, UNIFEM is committed to:

- Reversing the gender disparities that are growing across the spectrum of ICT development and use
- Supporting the development of gender-responsive policies and practices that will avert future imbalances
- Working to understand and promote ways in which ICTs can create new opportunities for women's economic and political empowerment

Reversing the gender disparities that are growing across the spectrum of ICT development and use requires a recognition that information technologies and the ways they are developed and used are not neutral. It will require gender-responsive policies and practices that address current gender imbalances and avert future ones.

UNIFEM's global gender E-quality programme

UNIFEM's global gender and ICTs programming is supporting E-quality in national and global ICT governance and policy, E-quality in the institutions which regulate and govern ICT development and E-quality in ICT projects and programmes designed and carried out on the ground. With a focus on activities at the national and regional level, UNIFEM's field offices are at the forefront of many of the organization's E-quality initiatives.

Examples of current initiatives supported by UNIFEM and carried out in collaboration with NGOs, governments, private sector companies and other UN agencies include:

Achieving E-quality in the IT Sector: A UNIFEM/Cisco Systems, Inc. Initiative. UNIFEM is working with Cisco Systems, Inc., Cisco Foundation and the Government of Jordan to establish pilot Gender Networking Academies in Jordan to train women in networking skills and link them to employment in the IT sector. A study of the challenges and opportunities for women within the ICT sector in Jordan has recently been completed.

Rwanda telecentre initiative. In consultation with the Rwandan Ministry of Gender and Telecommunications Authority, UNIFEM (through its Gender Advisor in Rwanda) has initiated discussions regarding the development of a telecentre initiative that would enhance women's access to ICTs and to global markets. In Rwanda, the government has requested UNIFEM to undertake a survey on Rwandan women's information and communications needs, as a first step towards working with policy-makers to develop a pilot multipurpose telecentre for women in Rwanda.

WINNER Project: Women into the New Network for Entrepreneurial Reinforcement. The WINNER project seeks to demonstrate how women entrepreneurs can benefit from the Internet and other electronic communication tools. Building on the existing TIPS (Technological, Trade and Information Promotion System) network

(<http://tips.org.uy/tips/eng/>), WINNER is building skills and facilitating the ability of women entrepreneurs to conduct business activities electronically and enlarge the scope of their trading.

APC Women's Networking Support Program, Gender Audit workshop and methodology. UNIFEM, through the WomenWatch initiative, is working in partnership with the APC Women's Networking Support Program's to support the development of a gender audit methodology to provide *criteria* for the effective integration of gender considerations into programmes and *indicators* to monitor its effective delivery of benefits to women.

Arab Women Connect. In 2000, the UNIFEM Arab States Regional Office launched the [Arab Women Connect](http://www.arabwomenconnect.org) project and web site (www.arabwomenconnect.org). Arab Women Connect is an Internet networking/training project that aims to explore the potentials and applications of new information and communication technologies for Arab women's empowerment.

During the span of this project, most activities of the project will center around the Beijing Platform for Action (BPFA) Review exercise and the processes leading up to it. Specific activities include building a multi-lingual web site on issues critical to women in Asia, an electronic training workshop, the development of training materials in print and on CD-ROM, as well as encouraging synchronized lobbying by national women's groups and "onsite" information dissemination at the Beijing+5 Review. Project 1: Teleworking: Implications for Employment and Trade in Developing Countries, Malaysia and India (Project Director: Prof Swasti Mitter)

Objectives:

The project's aim was to document the extent of teleworking in India and in Malaysia, and assess its potential for creating employment and novel career opportunities, particularly for traditionally disadvantaged groups such as women. The research looked at teleworking within and across national boundaries and examined its impact on key service sectors - such as software, finance and banking, media and publishing, and education. The empirical enquiry has identified the factors that facilitate or inhibit the implementation of telecommuting and teletrade (national and international aspects of teleworking respectively) for improving regional development, corporate efficiency and the prospect of small and medium-scale enterprises. The project assessed the positive and negative implications of teleworking on the quality of working lives. In addition, it contributed to enhancing the competitiveness of India and Malaysia in the globalised information society and stimulate informed policy dialogue between the North and the South in the arena of trade in information services.

Project 1: Gender mainstreaming in *infoDev*

Since October, 2001, the Information for Development Program *infoDev* is applying an effort called "Gender mainstreaming in *infoDev*." The purpose of the project is to identify the main elements of the "gender digital divide," undertake research for a greater understanding of the gender implications of *infoDev* projects, give greater prominence to gender issues in *infoDev*'s processes, and allow gender concerns to influence *infoDev*'s strategies. Main activities are a study of existing projects to learn lessons on gender for future programs and projects, develop capacity for gender analysis among *infoDev* staff, and design special *infoDev* initiatives to promote women as beneficiaries of ICT projects. The budget for research and related activities, which will be completed and evaluated in May, 2002, is \$57,000.

The main expected outcome of this project is an increased allocation of grants to applications of ICT that address women's needs in a substantial way. *infoDev* will, as in its other activities, consider a range of partnerships with the civil society, donor organizations, NGOs, and the private sector in these efforts.

The Information for Development Program, *infoDev*, is a multi-donor funded program that promotes innovative projects on the use of information and communication technologies (ICTs) for economic and social development, with a special emphasis on the needs of the poor in developing countries. The *infoDev* Secretariat is hosted by the World Bank as part of its Global ICT Department.

Project 2: Gender and the Digital Divide Seminar Series

The Gender and the Digital Divide Seminar Series looks at the impact that information and communication technologies (ICT) are having on gender relations and innovative ways that ICTs are being used to overcome gender inequalities and bridge the digital divide. Project 3: The Development Market Place: “Well Being of Disabled and Women in Areas of Poverty;” and “Solar Energy-Powered Wireless Internet for Rural Education and Community Development”

Funded by the Development Marketplace, the project “Well Being of Disabled and Women in Areas of Poverty,” addresses gaps in services to disabled children and their mother in India, by providing, under one roof, all services for disabled persons of all age groups; establishing a clinic for babies and mothers at risk; conducting disability awareness programs with a focus on birth attendants; and setting up a disability information and dissemination network online. The project has been allocated \$77,918 from the World Bank’s Development Marketplace. Inclusive dates are January 2002-January 2003.

Partners include *Die Lebenshilfe Wien*.

Also funded by the Development Marketplace, the project “Solar Energy-Powered Wireless Internet for Rural Education and Community Development,” aims to help Haitian teachers improve the quality, efficiency, and coverage of education provided to female and male students and to expand the horizon of students and teachers alike by giving them access to unlimited educational resources via solar-energy powered wireless Internet. The use of the internet, coupled with the use of selected audiovisual materials will result in improved language, reading comprehension, writing, grammar and mathematical and scientific skills. The project offers opportunities for educational and informational programming for the community, especially for older children and adults and provides them with the relevant life-skills training. The project has been allocated \$81,900 from the World Bank’s Development Marketplace. Inclusive dates are January 2002-January 2003. Partners include *Haiti Community Development Inc.* and *Haiti Partners of the Americas Inc.*

Project 4: The Gender and Development Gateway

The Development Gateway is a portal on development issues, from which users can access information, resources, and tools, and into which they can contribute their own knowledge and experience. It creates a common platform for shared material, dialogue, and problem-solving that is easy to access and navigate through. The Development Gateway was started in April 2000 and is ongoing.

As part of the Development Gateway, a Gender and Development Gateway portal has been setup. The Gender and Development portal is a common platform for gender and development related resources, information, and dialogue. The Gender Portal is intended to serve the needs of a broad array of stakeholders, including developing countries, the official donor community, civil society, the private sector, and other key partners, and assist these stakeholders by providing links to ideas and good practice, information about development activities and trends, funding, and commercial opportunities. Project 5: Gender Sensitivity in ICT Sector Development Projects

The World Bank Group's Global Information & Communication Technologies Department (GICT) plays an important role in developing and promoting access to information and communications technologies (ICT) in the emerging markets. The Group leverages the expertise of the Policy and Investment units to provide both governments and private companies with the capital and expertise needed to develop and exploit ICT to reduce poverty and foster development. In terms of investments, the Global Communications Investment Division is part of the [International Finance Corporation](#) (IFC) and operates within the World Bank Group's Global Information and Communications Technologies Department (GICT). Since 1992, IFC has financed over 65 communications projects in more than 34 countries, and has provided about US\$3.3 billion of financing.

Gender sensitive programs can be found in many ICT sector development projects, without being the main theme of those. In looking at capacity building strategies for the ICT sector, the GICT group and the Human Development network is trying to incorporate incentives for young women and girls to adopt ICT or engineering carriers. These are traditionally dominated by males, who will tend to seek jobs outside their countries, thus worsening the brain drain problems faced by nations with an already sub-optimal base of ICT skills. Several on-going analytical work on ICT, for example in Tunisia and Egypt, are explicitly stressing the need to increase the number of young girls trained on computer skills at both secondary education level and tertiary education projects. Incentive creation is another aspect that is being looked at, in the form of scholarships for women, special education grants and loans, etc.

Several grants from GICT have focused on gender issues. Examples include: SITA (Study of Information Technology Applications); computer Skills Training for Low-Income Women (India); Strengthening Electronic Communications Capacities of Women's Organizations in Africa (Kenya); Inter-City Marketing Network for Women Marketing Entrepreneurs (India); and Training of Women Entrepreneurs.

Project 6: Gender and ICT in Agriculture (information on various projects)]

In the World Bank's agriculture sector, ICTs are used basically as tools for implementing Agriculture Knowledge and Information System (AKIS) projects, with the largest usage in agriculture extension, followed by research, and then education. Of the 402 AKIS Bank funded projects, about 65 have explicitly used ICTs as tools for service delivery, technology dissemination, market access and capacity building. This makes it quite difficult to give even an estimated amount of financial resources allocated.

Gender Projects: About 7 of the 65 AKIS projects have explicit gender-oriented objectives and focus. However, many other AKIS projects without explicit gender focus do have women as some of the projects' beneficiaries. It is important to note that the benefits of ICTs are often difficult to measure, and as a result are underestimated. Also getting reliable statistics on rural women's access to and use of ICTs is very difficult.

Past Projects

Project A

Title: The Gambia Women in Development Project

Objectives: The development goal was to increase women's farmer's productivity and access to markets. This was to be achieved through two of the four components of the projects: The Agriculture component and the Information, Education, and Communication component (IEC).

Information and Communication Technologies: Radio, video halls, theater, audiovisuals, folk media and news papers.

Financial Resources: Total cost of project was USD15.1 million, with 3.2 million for the agriculture component and 2.1 million for IEC component.

Inclusive dates: 1990-97

Partners: IDA financed 50% of project cost, and co-financing provided by the Government of the Gambia, the Kingdom of Norway, the African Development Bank (ADB), United Nations Development Program (UNDP), United Nations Fund for Women (UNIFEM) and United Nations Fund for Population Activities (UNFPA)

Evaluation Results/Outcome: Both components objectives were substantially achieved:

- In field crop extension female share of contact farmers increased from an estimated 10% at the time of appraisal to about 70% at project completion, exceeding the project's 60% target.
- Over 90% of beneficiaries report a 2-3 fold increase in yields.
- 70 livestock demonstration sites were established for women, more than double the number planned and most were constructed by women.
- Women's participation and sales in livestock markets increased from 12% at the first show in 1991 to 50% in the 1996 show.

- Women's cumulative savings in the Gambian Women's Finance Association, increased to about D860,000 in 1996, with loan repayment rate of 95%.
- Women's overall welfare improved with contraceptive prevalence among women increasing from between 7% and 11% before the project to 17 % to 23 % after.
- There was increased local and national awareness of women's needs.

Project B

Title: Nicaragua Agricultural Technology and Land Management Project

Objectives: The main objectives of the project was to assist Nicaragua in its moves towards a market-oriented economy, and to increase and diversify agricultural output and exports, creating employment opportunities and improving agricultural productivity and the incomes of small and medium farmers through better access to basic agricultural services, hence ameliorating the country's extreme poverty.

Information and Communication Technologies: Audiovisuals, faxes, internet, new papers.

Financial Resource Allocation: Total project cost was \$57.80, with \$44.00 million from IDA. Amount of resources allocated for ICT not known

Inclusive dates: 1993-2000

Partners: INTA (Nicaraguan Institute of Agricultural Technology)

Evaluation Results/Outcome: Female participation in agricultural extension services increased six fold compared to a four fold increase in extension beneficiaries broadly.

Current Projects

Project C

Title: El Salvador Agriculture Sector Reform and Investment Project

Objectives: The aim of the project was to help poor farmers improve agricultural productivity, production and income levels. The project is designed to include women among its target population. According to the staff appraisal report, women's involvement in the project was premised on the large number of single headed households, and participation in field work and home gardens. Specific actions in the project include: training to researchers, extension workers, farmers and NGOs, as well as promote women in the role of contact farmers.

Information and Communication Technologies: Audiovisuals, faxes, internet, new papers, radio.

Financial Resource Allocation: The total cost of the project is \$56.00 million, with \$40.00 from IDA. Amount of resources allocated for ICT not known.

Inclusive dates: 1995-2003

Partners: CENTA (National Center for Agriculture and Forestry Technology, El Salvador)

Evaluation Results/Outcome: Project ongoing, available statistics from field indicate increased number of women in mixed client groups, from 32 percent in 1995 to 36 percent in 1998.

Project D

Title: Venezuela Agricultural Extension Project

Objectives: The objectives of the project are to assist poor farmers to become aware of, and adopt improved technology to enhance their productive efficiency and their economic welfare, to improve the environmental sustainability of their farming operations, and to accomplish this by supporting the establishment of a new decentralized public agricultural extension service to serve the needs of poor farmers who are currently not able to secure adequate extension services.

Information and Communication Technologies: Audiovisuals, internet, news papers.

Financial Resource Allocation: Total project cost is \$79.00 million, with \$39.00million from IDA. Amount allocated for ICT not known.

Inclusive dates: 1995-2002

Partners: Inter American Development Bank

Evaluation Results/Outcomes: Project still ongoing, however, field visits in 1997 estimates that about, 80 percent of the clients were male and 20 percent were women. In 1998, male participation had dropped to 76 percent and the proportion of female clients rose to 24 percent.

Project E

Title: Cameroon National Agricultural Extension and Research Program Support Project

Objectives: The National Agricultural Extension and Research Program Support Project will seek to improve farmers' agricultural productivity and incomes through providing support to an integrated, farmer-orientated agricultural extension system and a demand-driven research system. The project consists of six components. First, the agricultural extension component will include participatory diagnosis of farmers' production problems, transfer of farming techniques, particularly to resource-poor and women farmers, and monitoring of the progress of extension and research activities

Information and Communication Technologies: Audiovisuals, internet, new papers, radio.

Financial Resource Allocation: Total project cost is \$46 million with 15.1 million from IDA. Amount allocated for ICT not known.

Inclusive dates: 1998-2003

Evaluation Results/Outcome: Project is ongoing

Project F

Title: Uganda National Agricultural Advisory Services Project

Objectives: The overall development goal was to assist poor men and women farmers to become aware of and adopt new technologies to enhance productivity and economic welfare.

Information and Communication Technologies: Cell phones, audiovisuals, internet, new papers, radio.

Financial Resource Allocation: The total project costs are estimated at US\$ 107.91million, with \$75.00 million from IDA. Amount of resources allocated for ICT not known

Project G

Title: Arab Republic of Egypt East Delta Newlands Agriculture Services Projects

Objectives: The objective of the East Delta Agricultural Services Project is to provide support services to facilitate the settlement and increased agricultural production of about 26,000 farm families on 130,000 feddans of newly developed lands in the East Delta, leading to increased farm incomes and laying the basis for the development of a viable rural economy in the East Delta area. The project has five components one of which Agricultural support services, extension and adaptive research service, provided to smallholders, graduates, and cooperative members; and supporting the development of water users associations and service cooperatives.

Information and Communication Technologies: Radio, audiovisuals, news papers, faxes, and internet.

Financial Resource Allocation: Total project cost is \$ 91.2 million, with \$ 15 million commitment from IDA. Amount of resources allocated for ICT not known

Project H

Title: China Anning Valley Agricultural Development Project

Objectives: The Anning Valley Agricultural Development Project aims at increasing the agricultural production and marketability in the area, with a particular emphasis at reducing poverty. The project fosters the effective use of natural resources, through the development of mountainous areas and environmental improvement. Some of the key components of the project are: a) water resources development, consisting of three sub-components - Manshuiwan, Huangqiao & Shengli - which include the construction of weirs, high dam and canal systems, both for irrigation and hydroelectric power stations; b) the development of land and technology for crop development, aimed at increasing provincial food production; c) orchard development to improve the quality and quantity of fruits in the project area; d) the sericulture development, designed to be market driven, will increase and improve silk production; e) the livestock development aims at reducing farm

poverty, generating income activity for women as well; f) the agro-processing component, provides essential linkages among production, processing and marketing of farm products.

Information and Communication Technologies: Radio, internet, audiovisuals, new papers, faxes
