

## Gender distribution of staff in the Professional and higher categories

Percentage comparison of women in the professional and higher categories with appointments of one year or more in the United Nations system and IMO (Dec 2010)



#### As of 31 December 2010, women in the UN system constituted:

- **40.3%** (12,005 out of 29,763) of all staff in the professional and higher categories with appointments of one year or more.
- 22.7% (784 out of 2,674) of all staff at the **D-1 level and above**.
- **29.3%** (11,221 out of 27,089) of all staff at the **P level**;

Gender balance has only been achieved at the P-2 (57.3%) level.

Largest increase: UG (15.2% from 15.6% in Dec 2001 to 30.9% in Dec 2010)

Smallest increase: P-2 (4.0% from 53.3% in Dec 2001 to 57.3% in Dec 2010)

As of 31 December 2010, women in IMO constituted:

- 41.2% (61 out of 148) of all staff in the professional and higher categories with appointments of one year or more.
- 16.0% (4 out of 25) of all staff at the **D-1 level and above**.
- 46.3% (57 out of 123) of all staff at the P level.

Gender balance has only been achieved or exceeded at P3(56.3%)level, P2(87.5%)level.

Largest increase: **P2(32.5%** from **55.0%** in Dec. 2001 to **87.5%** in Dec. 2010)

Largest decrease: **P4(-11.0%** from 43.3% in Dec 2001 to **32.4%** in Dec 2010)

# Trends in the representation of women in the Professional and higher categories – 2001 to 2010

During the period **2001-2010** in the UN system, the proportion of women appointed increased by **6.8 percentage points**, from **33.5%**(6,407 out of 19,098) in 2001 to **40.3%** (12,005 out of 29,763) in 2010.

During the period **2001- 2010 in IMO** the proportion of women appointed increased by **7.1 percentage points,** from **34.1%** (43 out of 126) in 2001 to **41.2%** (61 out of 148) in 2010.
